Dear Mr. Grogg:

This letter is the initial agency decision (IAD) regarding your September 3, 2018, Freedom of Information Act (FOIA), 5 U.S.C. § 552, request to the Department of Veterans Affairs (VA). Portion of the request to the Office of Information & Technology (OI&T) was assigned FOIA tracking number 18-12525-F. For reasons outlined below, your request is granted in part.

To clarify, other VA FOIA offices will respond to you separately with responsive records relating to non- OI&T employees, such as VHA FOIA (18-12530-F), OSVA (18-12527-F), VBA FOIA (18-12529-F), OEI FOIA (18-12714-F), OGC FOIA (18-12531-F), and OEHRM FOIA (18-12715-F).

Initial Request

On September 3, 2018, you submitted a FOIA request for:

- 2. All communications, calendar entries (including any associated attachments or notes), call sheets, visitor logs, and meeting minutes or notes containing any of the following terms: Ike, Perlmutter, Moskowitz, or Sherman.

Please limit this search to the Office of the Secretary.

3. All communications, calendar entries (including any associated attachments or notes), call sheets, visitor logs, and meeting minutes or notes containing any of the following terms: Ike, Perlmutter, Moskowitz, Sherman, frenchangel59.com, American College of Surgeons, ACS, or Zinner.

Please limit this search to the following VA employees: David Shulkin, Robert Wilkie, Peter O' Rourke, Thomas Bowman, Scott Blackburn, Camilo Sandoval, Pamela J. Powers, William Gunnar, Carolyn Clancy, Clifford Ko, and David Hoyt.

4. All communications, calendar entries (including any associated attachments or notes), call sheets, visitor logs, and meeting minutes or notes containing any of the following terms: Ike, Perlmutter, Moskowitz, Sherman, Apple, App for veterans, Mobile application, Mobile app, Aaron.

Please limit this search to the following VA employees: David Shulkin, Robert Wilkie, Peter O' Rourke, Thomas Bowman, Scott Blackburn, Camilo Sandoval, Pamela J. Powers, Richard Stone, Melissa Glynn, and John Windom.

5. All communications, calendar entries (including any associated attachments or notes), call sheets, visitor logs, and meeting minutes or notes containing any of the following terms: a) Ike, Perlmutter, Moskowitz, Sherman, or frenchangel59.com; and that also include any of the following terms: b) Electronic health records, HER, Interoperability, or Cerner.

Please limit this search to the Office of Electronic Health Record Modernization, the Veterans Health Administration, and the Office of Information and Technology.

- 6. All emails sent or received by Genevieve Morris and Ash Zenooz containing any of the following terms: Cerner, Privatize, Privatization, White House, Trump, Ike, Perlmutter, Moskowitz, Sherman, or frenchangel 59.com.
- 7. All records or communication concerning the VA final rule VA Claims and Appeals Modernization, 83 Fed. Reg. 39818 (August 10, 2018) where any of the following individuals are included or mentioned: Isaac "Ike" Perlmutter, Laura Perlmutter, Bruce Moskowitz, Aaron Moskowitz, Marc Sherman, or individuals whose email address ends in "@frenchangel59.com".

Please limit this search to the Veterans Benefits Administration

8. All records and communications concerning the Federal Advisory Committee Act where any of the following are included or mentioned: Isaac "Ike" Perlmutter, Laura Perlmutter, Bruce Moskowitz, Aaron Moskowitz, Marc Sherman, or individuals whose email address ends in "@frenchangel59.com".

Please limit this search to the Office of the Secretary and the Office of General Counsel."

Requester Category & Fees

Please be aware that the FOIA, 5 U.S.C. § 552 (A)(4)(a)(II), places all FOIA requesters in one of three categories for fee purposes. The three categories of FOIA requesters are 1) commercial use

requesters; 2) educational institutions, noncommercial scientific institutions, and representatives of the news media; and finally, 3) all requesters "all other" who do not fall within either of the preceding two categories.

We have determined your request to be a "News Media" request. Our determination to classify this request as a News Media request is based on the FOIA Improvement Act of 2016 and VA FOIA regulations found at 38 C.F.R §1.561.

No fees were estimated/ charged for your request.

Search

On April 4, 2019, OI&T received its portion of the request and began processing. A complete search for information responsive to your request was conducted by VACO FOIA Service. During the search, we determined your request to be a complex FOIA as it presented unusual circumstances because OI&T must search for and collect responsive records, input those records into Clearwell (email search platform) - and because the requested records are voluminous (estimated thousands of responsive pages)- de-duplicate records, then conduct a line by line review of all responsive records. A total of five hundred and forty-eight pages (548) were found to be responsive to your request. One hundred and ninety-nine (199) pages are released to you in full, eleven (11) pages withheld in full (still released to you), and three hundred and thirty-eight (338) pages are released to you in part.

Relevant Law

We have thoroughly reviewed your submission under the provisions of the FOIA, which provides that federal agencies must disclose records requested unless they may be withheld in accordance with one or more of nine statutory exemptions. 5 U.S.C. § 552(b).

Analysis

By way of background, you initially requested answers to eight (8) items as mentioned above in your request. OI&T was deemed responsible for items: 1, 3, 4 and 5.

OI&T's search for responsive records to your request yielded five hundred and forty-eight pages (548) pages. After conducting a comprehensive line by line rereview, OI&T withheld some information in part in accordance with one or more of nine statutory exemptions. 5 U.S.C. § 552(b). The information withheld was redacted under FOIA Exemptions (b)(4) [(5 U.S.C. § 552(b)(4)), (b)(5) [(5 U.S.C. § 552(b)(5))], and (b)(6) [(5 U.S.C. § 552(b)(6)].

5 U.S.C. § 552(b)(4) permits withholding of records related to trade secrets and other confidential business information. Here the information withheld consists of internal VA's acquisition sensitive information.

5 U.S.C. § 552(b)(5) permits withholding of information under the deliberative process privilege, including pre-decisional documents, inter-agency or intra-agency memorandums or letters which would not be available by law to a party other than an agency, or information that could be withheld under civil discovery, attorney-client privilege, or attorney work product privileges. Here the information withheld consists of communications under the deliberative process and VA Office of General Counsel attorneys-client and work product privileges. Furthermore, some information consists of executive privileged White House communications and was withheld pursuant to White House Liaison review and guidance.

5 U.S.C. § 552(b)(6) permits withholding of records and information about individuals when disclosure would be a clearly unwarranted invasion of personal privacy. FOIA Exemption 6 permits VA to withhold a document or information within a document if disclosure of the information, either by itself or in conjunction with other information available to either the public or the FOIA requester, would result in an unwarranted invasion of an individual's personal privacy without contributing significantly to the public's understanding of the activities of the federal government. Specifically, the information withheld here consists of names. identities, email addresses, phone numbers, cellular numbers, facsimile numbers, and addresses of low level federal and private sector employees. Low grade federal civilian employees and private citizens retain a significant privacy interest under certain circumstances, such as in instances where the release of their information could represent a threat to their well-being, harassment, or their ability to function within their sphere of employment. Federal civilian employees and private citizens whose information is at issue have a substantial privacy interest in their personal information. In weighing the private versus the public interest, we find that there is no public interest in knowing the names, identities, email addresses, phone numbers, cellular numbers, facsimile numbers, and addresses of federal civilian and private sector employees. The coverage of FOIA Exemption 6 is absolute unless the FOIA requester can demonstrate a countervailing public interest in the requested information by demonstrating that the FOIA requester is in a position to provide the requested information to members of the general public and that the information requested contributes significantly to the public's understanding of the activities of the Federal government. We, however, release the names and email addresses of VA and non-VA Senior Executives involved with this case.

Decision

In light of the foregoing, we believe the efforts taken to locate responsive records were sufficient to satisfy the duty of the Department under the FOIA. Accordingly, your request has been granted in part/denied in part under FOIA Exemptions b4, b5, and b6; thus, we are releasing 548 total pages to you enclosed on a CD with this letter.
