



I am sure you don't remember me, but we briefly met at the McCain Institute Dinner in NYC a few weeks back. (I interviewed Secretary Kissinger and Gov Kasich before the dinner audience.). Having been an anchor at all 3 cable news networks, I am now the anchor at Voice of

America TV's Plugged in — a show that focuses on American policy and that broadcasts world wide and is translated into many languages (eg it is translated into Mandarin and airs in Asia; translated into Farsi and airs in Iran etc.)

I would very much like to interview you about the President's expected new tariffs on steel. I know that you have spoken to some news organizations already but VOA TV reaches beyond the US border and to a much bigger worldwide audience than the US cable audience. This worldwide reach is important because the world wants to know and understand American policy as it directly impacts them. I am likewise confident that the Trump Administration wants to reach the worldwide audience about important policy changes.
