The ORO instructed the IT department to search all District-owned accounts and advised each named person in the Request, including me, to conduct a search of our personal communication accounts for responsive records. The only responsive records to the Request are those records at issue in this appeal and are accurately described as communication exchanges between Attorney Jeremy Samek and me, and the documents attached to those communications.
- 6. I sought to become a client of Attorney Jeremy Samek for the purposes of securing legal advice and services related to certain District policies.
- 7. It is my belief that Attorney Samek is a proper and active licensed attorney in the Commonwealth of Pennsylvania.
- 8. Via a text communication, I requested Attorney Samek review certain District policies and offer his legal opinion and services on additions and revisions to those policies.

- 12. In the email communication dated January 11, 2023, at 14:33, Attorney Samek responded to my request and provided his legal opinion and services. The request was not for the purpose of committing a crime or tort.
- 13. As part of Attorney Samek's communications with me, and as part of my request for legal services and opinions, Attorney Samek provided a Confidential Legal Memorandum that discussed and explained different court cases related to constitutional concerns and Title IX.
- 14. In addition to the Confidential Legal Memorandum, Attorney Samek, at my request, provided me with policies he created that set forth relevant facts and his opinions, mental impressions, legal advice, and legal theories which applied the court cases related to constitutional concerns and Title IX from the Confidential Legal Memorandum.
- 15. None of the above documents and/or email communications were shared, copied, or provided to any other person outside of this appeal.
- 16. I have never waived the attorney-client privilege attached to the above documents and/or communications.
- 17. Upon advice from Attorney Samek, I advised the District's ORO to deny the request for the sole responsive records as attorney-client privileged records.




