Re: Thirty-Day Notice of Intention to File Legal Action Regarding Violations of W.V. Code § 49-5-106

To Whom It May Concern:

The West Virginia State Conference of the NAACP (WV NAACP), represented by Mountain State Justice and Democracy Forward Foundation¹, intends to file a lawsuit to address the Department of Homeland Security, Department of Human Services, and Department of Education's violations of West Virginia Code § 49-5-106.

Specifically, this statutory provision mandates that the Division of Juvenile Services (now the Bureau of Juvenile Services within the Department of Homeland Security) and the Department of Health and Human Resources (now the Department of Human Services), along with the Supreme Court of Appeals, establish procedures to collect and compile (or track and record) certain data related to juvenile recidivism and the outcome of diversion programs. The statute also charges these entities—and the Department of Education—with developing specific procedures to track and evaluate the effectiveness of truancy diversion programs, and to collect and compile data relating to disproportionate minority contact with the juvenile justice system in West Virginia.

WV NAACP, by and through counsel, submitted public records requests seeking the procedures these agencies are required to establish, and the data these agencies are required to collect and compile (or track and record), under that statute. Based on the responses received, it is clear that these agencies have failed to comply with their mandatory statutory duties. WV NAACP therefore intends to file a petition for writ of mandamus, seeking all relief available to it, including requiring the respondent agencies to comply with West Virginia Code § 49-5-106 by establishing the required procedures and collecting and compiling (or tracking and recording) the required data on an ongoing basis.

This notice is given pursuant to provisions of West Virginia Code § 55-17-3. Any filing will be withheld for at least thirty days from the date of provision of this notice. WV NAACP would be amenable to meeting and conferring with the respondent agencies prior to the filing of their petition.
