Dear Skye Perryman:

This is in response to your Freedom of Information Act (FOIA) request, dated July 21, 2025. Your request was processed in accordance with the FOIA (5 U.S.C. § 552) and FHFA's FOIA regulation (12 CFR Part 1202).

You requested the following:

"All calendars or calendar entries (including calendar invitations, calendar invitation attachments) for FHFA Director William J. Pulte, including any calendars maintained by Director Pulte himself or on behalf of Director Pulte by any administrative assistant or scheduler. DFF requests that calendars be produced in a format that includes all invitees, notes, and attachments. Please do not limit your search to Outlook calendars or the calendars attached to Director Pulte's official FHFA email address; we request the production of any calendar – paper or electronic, on government or personal devices – used to track how Director Pulte allocates time on agency business. This request seeks records from March 1, 2025, until the date of the search."

A search of FHFA files and records located 41 pages responsive to your request. The material is being released in its entirety. The responsive material is attached.

This is FHFA's final decision on your FOIA request. If you wish to appeal any aspect of FHFA's decision on your request, you must forward within 90 days:

- A copy of your initial request;
- A copy of this letter; and

- A statement of the circumstances, reasons, or arguments for seeking disclosure of the affected record(s).

The appeal must be sent either electronically by 5pm to foia@fhfa.gov or by mail to the “FOIA Appeals Officer” at 400 7th Street, SW, 8th Floor, Washington, DC 20219. The subject line, or the envelope and the letter of appeal, must be clearly marked “FOIA Appeal.” Please note that all mail sent to FHFA via the United States Postal Service is routed through a national irradiation facility, a process that may delay delivery by approximately two weeks. For any time-sensitive correspondence, please plan accordingly.

Additionally, you may seek dispute resolution services from the Office of Government Information Services (OGIS) at the National Archives and Records Administration. Your FOIA request is releasable to the public under subsequent FOIA requests. In responding to these requests, FHFA does not release personal information, such as home or email addresses and home or mobile telephone numbers which are protected from disclosure under FOIA Exemption 6 (5 U.S.C. § 552(b)(6)).
