This is in final response to your Freedom of Information Act (FOIA) request, dated November 20, 2025. Your request was processed in accordance with the FOIA (5 U.S.C. § 552) and FHFA's FOIA regulation (12 CFR Part 1202).

You requested the following:

"Democracy Forward Foundation ("DFF") requests that the Federal Housing Finance Agency ("FHFA") produce the following within twenty (20) business days and on an expedited basis: Copies of all SF-50 forms for all current and former Federal employees, belonging to the categories listed below, who entered the Federal Housing Finance Agency between January 20, 2025 and the date of search for this request, along with the employee's name, position, start date, end date (if applicable), pay grade, total salary and applicable appointment authority. Categories: Senior Executive Service Chief of Staff Senior Advisors Schedulers Executive Secretaries Executive Assistants GS-13 (or the equivalent on the LL and EL paycales) and above For purposes of this request, "Federal employees" includes employees in the Senior Executive Service; competitive service; and excepted service (including career and non-career, temporary, time limited, intermittent and seasonal appointments in Schedule A, B, C, or D), special government employees, detailees, experts, consultants, or unpaid and volunteer equivalents. DFF expects this request for a set of readily identifiable records regarding a high-profile matter will be assigned to the Simple processing track and processed Expeditiously."

A search of FHFA files and records located 10 pages of responsive material. The records are being partially released (redacted) pursuant to exemption 6 of the Freedom of Information Act, 5 U.S.C. § 552 (b)(6), as disclosure of certain information (e.g., ssn, dob, retirement/insurance information, etc.), "would constitute an unwarranted invasion of personal privacy." A copy of the accessible material is attached.

This is FHFA's final decision on your FOIA request. If you wish to appeal any aspect of FHFA's decision on your request, you must forward within 90 days:

- A copy of your initial request;
- A copy of this letter; and
- A statement of the circumstances, reasons, or arguments for seeking disclosure of the affected record(s).

The appeal must be sent either electronically by 5pm to foia@fhfa.gov or by mail to the "FOIA Appeals Officer" at **400 7th Street, SW, 4th Floor, Washington, DC 20219**. The subject line, or the envelope and the letter of appeal, must be clearly marked "FOIA Appeal." Please note that all mail sent to FHFA via the United States Postal Service is routed through a national irradiation facility, a process that may delay delivery by approximately two weeks. For any time-sensitive correspondence, please plan accordingly.
