Re: Freedom of Information Act Request

Dear DC FOIA Officer:

Pursuant to the District of Columbia Freedom of Information Act, or FOIA, DC Code § 2-531-539. Democracy Forward Foundation submits this request for records.

Records Requested

Democracy Forward Foundation ("DFF") requests that the Executive Office of the Mayor ("EOM") produce the following within fifteen (15) business days:

All communications (including emails, email attachments, complete email chains, calendar invitations, calendar invitation attachments, text messages or messages on messaging platforms, including Slack and Microsoft Teams) between (a) any of the DC officials below and (b) the following federal officials, regarding the federalization of the Metropolitan Police Department.¹

The timeframe for the above search should be August 5, 2025 until August 14, 2025.

Please note that Democracy Forward Foundation does not seek the <u>initial</u> mailing of news clips or other mass-distribution emails. However, subsequent communications responding to or forwarding such emails <u>are</u> responsive to this request. For example, if a specific individual received a mass-distribution news clip email containing the term "Federalization" that initial email would <u>not</u> be responsive to this request. However, if that specific individual forwarded that email to another individual with his own commentary, that subsequent message would be responsive to this request and should be produced.

Scope of Search

In searching for responsive records, please search for records regardless of format, including paper records, electronic records, audiotapes, videotapes, photographs, data, and graphical materials. This request includes, without limitation, all correspondence, letters, emails, text messages, calendar entries, facsimiles, telephone messages, voice mail messages, and transcripts, notes, minutes, or audio or video recordings of any meetings, telephone conversations, or discussions. However, please exclude publicly available materials such as news clips that mention otherwise responsive search terms, unless the records contain additional discussion or commentary from District employees or contacts at CMS listed above.

The District of Columbia Freedom of Information Act requires agencies to disclose information, with only limited exceptions for information found within DC Official Code § 2–534. In the

event that DHCF wishes to deny the right to inspect or obtain a copy of requested records, we request a written statement from DHCF of the grounds for denial, citing the laws or regulations under which access is denied. DC Official Code § 2-533(a)(1). We also reserve the right to appeal any decisions to deny inspection of records. DC Official Code § 2-537(a).

If requested records are located in, or originated in, another agency, department, office, installation or bureau, please refer this request or any relevant portion of this request to the appropriate entity.

To the extent that the records are readily reproducible in a searchable, electronic format, we would prefer to receive the records in that format. However, if certain records are not available in that format, we are willing to accept the best available copy of each such record.

Please respond with to this request in writing within 15 business days to set a date as required by DC Official Code § 2-532(c)(1). If all of the requested documents are not available within that time period, we request that you provide us with all requested documents or portions of documents that are available within that time period.

Request for Fee Waiver

Democracy Forward Foundation requests a waiver of document search, review, and duplication fees associated with processing records for this request, in accordance with section DC Official Code § 2-532(b).

The requested waiver is in the public interest because providing the copy of the information sought primarily benefits the general public. Democracy Forward Foundation has a demonstrated ability to disseminate information of public interest requested through freedom of information statutes, and based upon responses to this request may assist in publicizing records received to contribute to the public's understanding of the District's actions relating to the federalization of the Metropolitan Police Department and the deployment of the National Guard.²

DFF has a demonstrated ability to disseminate information of public interest requested through FOIA. When DFF obtains materials through FOIA requests that are of significant public interest, DFF's communications staff regularly works to ensure that these materials and their contents are featured in press articles educating the public about the operation of government; many articles feature additional commentary and analysis from DFF staff about those materials and their relevance to policy issues of public interest.
